Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ▪ Social Security number and income ▪ Account balances and payment history ▪ Credit history and credit score

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Aqua Finance, Inc. chooses to share; and whether you can limit this sharing.

What We Do

How does Aqua Finance, Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Aqua Finance, Inc. collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ▪ Apply for financing or provide account information ▪ Give us your income or employment information ▪ Show your government issued identification ▪ We also collect your personal information from others, such as credit bureaus, affiliates, or other companies
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ Sharing for affiliates' everyday business purposes – information about your creditworthiness ▪ Affiliates from using your information to market to you ▪ Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account that I hold jointly with someone else?	Your choices will apply to everyone on your account – unless you tell us otherwise.

Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <p><i>Our affiliates include companies with an Aqua or AFI name and financial companies such as Bay Finance Company, LLC and MBC Investments, LLC.</i></p>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and non-financial companies.</p> <p><i>Nonaffiliates we share with may include mortgage companies, insurance companies, finance companies, banks, mortgage service providers, retailers, and direct marketing companies.</i></p>
Joint marketing	<p>A formal agreement between nonaffiliated companies that together market financial products or services to you.</p> <p><i>Our joint marketing partners may include insurance companies, mortgage companies, credit card companies, and finance companies.</i></p>

Other Important Information

For California, North Dakota, and Vermont Residents: In response to California law and North Dakota and Vermont regulation, we will automatically treat accounts with California, North Dakota, and Vermont addresses as if you marked all boxes on the mail-in form on the first page to limit the sharing of your information. **There is no need to contact us or return the mail-in form to us.**

For California Residents: We will not disclose your personal information to non-affiliated third parties with whom we have joint marketing agreements and we will not disclose information about your transactions and experiences with us to our affiliates.

For North Dakota Residents: We will not share personal information with nonaffiliates for them to market to you without your authorization.

For Vermont Residents: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
